	The Geneva Foundation's primary exempt purpose is to provide financial support for the charitable programs of Presbyterian Homes. In the fiscal year ended March 31, 2010, the Geneva Foundation provided \$6,547,110 of support for these programs, which allowed Presbyterian Homes to provide subsidized residential, day care, and health care services to senior adults (age 65 and over) who would otherwise have been unable to pay all or a portion of the cost of their care. In FY2010, approximately 288 senior adults received such charitable support from funds provided to Presbyterian Homes by the Geneva Foundation. In addition, the Geneva Foundation provided an additional \$803,000 to Presbyterian Homes to be used to pay for renovations to a recently purchased apartment building in the Rogers Park neighborhood of Chicago in which Presbyterian Homes provides rent subsidized apartments to 37 senior adults who otherwise would not be able to live in this community.

In doing this, the Compensation Committee works with an external compensation consulting firm that accumulates and presents to the Committee a broad range of compensation and benefits information pertaining directly to the CEO position, including benchmark information regarding comparative compensation and benefits by quartile. The Committee also considers the value of industry experience, organizational familiarity and knowledge, and executive retention in light of organizational plans for growth, strategic expansion and organizational needs in meeting the challenges of the unique business of providing senior care services. Compensation Committee proceedings are contemporaneously documented and minutes are maintained and on file at Corporate headquarters.
