"This corporation is formed as a not for profit corporation for the purpose of engaging in and supporting social and scientific research on social issues and increasing awareness domestically and internationally about the rights and responsibilities of citizens towards the society and state. The mission of this not for profit corporation is focused on spreading awareness amongst the people on being a responsible citizen and how to effectively contribute and participate in good democratic governance. The mission shall be accomplished through educating and encouraging citizens to participate in good and transparent governance, public policy reforms through awareness and education, innovative use of the internet, media and other communication tools that promote social harmony and the rule of law leading to better quality of life.

The not for profit corporation will collaborate and will make contributions to or receive contributions from other organizations that meet the stipulations under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code."

Changes in the By-Laws

"Voting rights are given only to the Board members. Anyone associated with Rakshak in any capacity (eg. volunteer, advisor, member etc.) other than the Board members cannot vote. No Board Member can be absent in more than 3 consecutive meeting and cannot be absent in more than 2 Quarterly meetings in a year. Doing so will result in automatic loss of Board membership of the individual."
