	Domestic Violence is an epidemic. Studies have found that 15.5 million US children live in families in which partner violence occurred at least once in the past year, and 7 million children live in families in which severe partner violence occurred. Every child deserves to feel safe at home. Home is a place to be yourself, a place free of the world’s violence and anger. However, for so many children, home is not a place of comfort, but instead a place of fear. Joe Torre knows that fear. He grew up in household where he was afraid to go home in fear of his father’s rage and violence towards his mother. It is for this reason he and his wife Ali started the Joe Torre Safe At Home Foundation. Founded in 2002, The Joe Torre Safe At Home Foundation is a public nonprofit organization with the mission of educating to end the cycle of violence and save lives. In the seven years since its creation the Foundation has educated thousands of students, parents, teachers and school faculty about the devastating effects of domestic violence and has opened twelve "safe rooms" in schools and Family Justice Centers throughout the New York tri-state area. With our in-school program, “Margaret’s Place”, we have positively impacted the lives of over 8,000 children this past year, alone. Margaret’s Place, a tribute to Joe Torre’s mother, is a comprehensive program which provides middle and high school students a safe room in schools, where they can talk to each other and to a professional counselor trained in domestic violence intervention and prevention. This non-threatening environment has proven to be an effective setting in which to promote discussion of issues surrounding violence, while also offering peer support and education to change school culture. By intervening with children at a young age, providing them with a safe environment and giving them support, we can end the cycle of abuse. Children do not have to suffer silently, become a victim or become a perpetrator. As we continue to expand our awareness, programming and outreach efforts, we need the invaluable support and generosity of others who believe in our mission and want to make a difference in the future of our youth.
