Ways of the Woods: People and the Land in the Northern Forest - the Center's mobile museum - has delivered place-based educational programming to more than 130,000 people in 85 communities across the Northern Forest since its debut in August 2006. The exhibit travels the region in a customized tractor trailer to reach underserved rural communities that have limited access to museum services. Through displays, videos and interactive, multi-media exhibits, visitors learn about the history of people living and working in the Northern Forest. The exhibition provides information about regional economic issues and related scientific research, such as the development of biofuels, advanced wood product manufacturing, forest health and productivity, and the potential of well-planned tourism development. Ways of the Woods has traveled to dozens of schools across the region, delivering educational programming to more than 6,000 students.

**4b** (Code \_\_\_\_\_) (Expenses \$ 179,538. including grants of \$ 0.) (Revenue \$ 240,008.)

Through its Regional Strategy work, the Center advances the region's ability to create a sustainable economy by removing barriers to progress and improving public policy and funding for the region. Specifically, the Center coordinated regional input on the formation of the Northern Border Regional Commission to ensure that the Commission will use the 4 State Sustainable Economy Initiative strategy developed in 2009 as the foundation for its regional development strategy, and helped secure \$1.5 million initial funding for the Border Commission. The Center advanced Northern Forest policy priorities through collaboration with other rural policy and forest coalitions, and through the New England Governor's Council on Land Conservation. The Center reinstated the Northern Forest New Digest, which circulates free to keep 300 subscribers up-to-date on regional news. The Center developed a 4 State network of financial institutions to increase funding for Northern Forest projects and infrastructure and hosted a Northern Forest Investment Roundtable that introduced a dozen foundations and philanthropists to the coordinated regional work underway in the Northern Forest.

**4c** (Code \_\_\_\_\_) (Expenses \$ 257,339. including grants of \$ 108,930.) (Revenue \$ 268,543.)

The Center spurs economic development, community development and forest conservation by supporting a 4-state network in tourism, renewable energy, and forest products and services. The Center leads the Northern Forest Investment Zone initiative comprised of 7 primary partners working in 4 states. Pilot projects are testing marketability of carbon and watershed services from the Northern Forest, advancing innovation in wood product manufacturing, and addressing biomass energy opportunities. Demonstration projects are underway in NH, VT and ME. The Center co-published Payments for Forest Carbon: Opportunities & Challenges for Small Forest Landowners; more than 15,000 copies have been downloaded. The Center coordinated the Maine Woods Consortium Tourism Committee, which created the Maine Woods Sustainable Tourism Investment Initiative, to increase the number of living-wage tourism jobs. Programs have trained 100 employees and managers in 3 Maine counties. The Center supported communities and businesses evaluating biomass energy proposals with services including direct consultation, visual inventories of renewable energy projects (presented to 1,500 people), and subscription-based updates.
