#### **BAYOU BEND COLLECTION**

This renowned collection of 17<sup>th</sup>, 18<sup>th</sup>, & 19<sup>th</sup> century American antiquities displayed in the Hogg Mansion, is part of the Houston Museum of Fine Arts. Eighteen members volunteer to serve as docents for two and four-hour shifts ten Sundays each year. This is the only time the collection is open to the public. Visitors come from around the world to view this fine collection of American antiquities.

#### RESEARCH HEMATOLOGY LABORATORY AT TEXAS CHILDREN'S HOSPITAL

All cancer and blood disorder patients are treated at the Hematology Laboratory. Eighteen members work in this program at Texas Children's Hospital and are working monthly with the young chemotherapy patients while they are undergoing treatment in the infusion center.

#### RONALD McDONALD HOUSE

Provides a "home away from home" for families of seriously ill children being treated at the Texas Medical Center. Thirty-two members work monthly three-hour shifts at the house. Members staff the volunteer office where duties include taking and forwarding all business calls, registration of children seeking treatment, or continued treatment, in the medical center, checking families in and out of the house, and other responsibilities as they are assigned.
