Ramsey Responds Inc.'s primary purpose is to provide financial and professional support as well as guidance to those neighbors who are experiencing temporary difficulties.

This direct assistance has taken the form of rent paying for a finite period of time, paying utility bills for an elderly disabled couple, providing funds so that financially strapped eighth grade students could participate in class trips, and purchasing of food for a disabled mother of two children.

Furthermore, this organization was the catalyst in conducting a major fund raiser for a 21 year old student in order to defray the significant costs of her Cancer treatments.

In addition, Ramsey Responds assists individuals and families in obtaining food and clothing from local Churches and other charitable organizations. It also identifies and communicates with other Municipal, County and State agencies that can also provide needed assistance.
