Subsequent to its original issuance, the effective date of its implementation for nonpublic enterprises was deferred until years beginning after December 15, 2008. The CSPA adopted ASC 740-10 as of May 1, 2009. Implementation of ASC 740-10 had no impact on the financial statements. As of both the date of adoption, and as of April 30, 2010, the unrecognized tax benefit accrual was zero. The CSPA will recognize future accrued interest and penalties related to unrecognized tax benefits in income tax expense if incurred. Federal and state income tax returns for the years 2007 - 2009 remain open to examination. No changes are anticipated in the total amount of unrecognized tax benefit in the next 12 months.
