Note 1 - Nature of the Foundation

The D'Addario Music Foundation, Inc. (the Foundation) was established in 1981 as a non-profit corporate foundation committed to inspiring and assisting the growth and appreciation of music throughout the world. The focus of the Foundation's giving is in the areas of stringed musical instruments as well as band and orchestral instruments, primarily through the support of educational programs and events, as well as performance-based activities. The name of the Foundation was officially changed from The D'Addario Foundation for the Performing Arts, Inc. to The D'Addario Music Foundation, Inc. in 2007.

Note 2 - Summary of Significant Accounting Policies

Cash and Cash Equivalents

For purposes of the Statement of Cash Flows, the Foundation considers all highly liquid investments purchased with an initial maturity of three months or less to be cash equivalents.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investments

Investments in marketable securities with readily determinable fair values are valued at their fair values in the statement of financial position. Unrealized gains and losses are included in the change in net assets in the statement of activities.

Revenue Recognition

Contributions are recognized when the donor makes a promise to give to the Foundation that is, in substance, unconditional.

Contributions received are recorded as unrestricted, temporarily restricted, or permanently restricted support, depending on the existence and/or nature of any donor restrictions.

Note 2 - Summary of Significant Accounting Policies (continued)

Revenue Recognition (continued)

All donor-restricted support is reported as an increase in temporarily or permanently restricted net assets, depending on the nature of the restriction. When a restriction expires (that is, when a stipulated time restriction ends or purpose for restriction is accomplished), temporarily restricted net assets are reclassified to unrestricted net assets and reported in the statement of activities as net assets released from restrictions.

The Foundation uses the allowance method to determine uncollectible promises receivable. The allowance is based on prior years' experience and management's analysis of specific promises made.

Income Taxes

The Foundation is a not-for-profit organization that is exempt from income taxes under Section 501 (c) (3) of the Internal Revenue Code. Unrelated business income, of which the Foundation had none for the years ended May 31, 2010 and 2009, would be subject to federal income taxes. Consequently, the accompanying financial statements do not reflect any provisions for income taxes.

Note 3 - Concentration of Credit Risk

The Foundation maintains cash balances at more than one financial institution. Accounts at each institution are insured by the Federal Deposit Insurance Corporation up to \$250,000 per institution. At May 31, 2010 and 2009 the Foundation's uninsured cash balances were \$0.

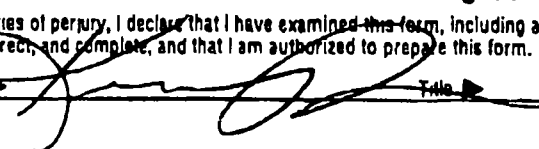
