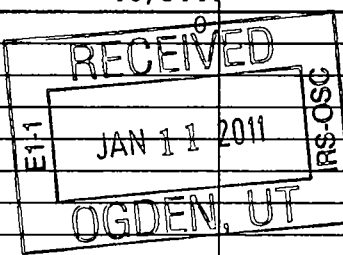

B. The current Trustees of the trust are MICHAEL C. DELANEY and TARA DELANEY GILBRIDE (formerly known as TARA E. DELANEY);

C. Pursuant to Article NINTH of the Agreement, the Trustees, from time to time, by written instrument duly acknowledged, may amend the Agreement in whole or in part, provided that no amendment shall authorize the Trustees to conduct the affairs of the trust in any manner or for any purpose contrary to the provisions of Section 501(c)(3) of the Internal Revenue Code, as amended from time to time; and

1. Article TENTH of the Agreement is revoked in its entirety and the following shall be substituted in its place:

2. Any assets titled in the name of the Trustees of THE MIKE DELANEY FOUNDATION shall, without any additional transfer or amendment, continue to be owned by

3. To the extent any provision of this amendment is inconsistent with any provision of the Agreement, the provisions of this amendment shall control.

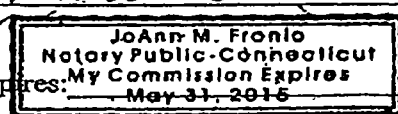
