Instruction includes salaries, fringe benefits, travel expenses, supplies and other ancillary program costs of teaching over 242 students, including 133 Masters of Divinity students, 12 Doctor of Ministry students, 49 PhD students, and 48 students in other graduate programs There are a total of 6 degree offerings and a number of other educational program offerings for ministerial continuing education and lay church leaders A full time faculty/staff of more than 34 teach and administer the related programs A long term goal of the schools has been to make theological education affordable and accessible, and as a result 86% of Brite's students received financial aid funded by Brite

The library acquires and provides essential resources, including paper and electronic books, journals, and indexes that support degree programs at the Masters and Doctoral levels along with related faculty research Additionally, one full time librarian provides reference assistance and bibliographic instruction to the students The library holdings include over 158,000 printed volumes, over 70,000 bound periodicals and other items plus additional e-books, journals and related indexes

Student housing facilities are available in Brite's Leibrock Village apartments This 56-unit apartment complex provides students and their families with affordable, high-quality housing in close proximity to the school Additionally, this housing provides a location that contributes to the residential community life of the school The complex had an occupancy rate of over 98%, and housed 68 students and their families Leibrock Village employed one full-time director and a part-time assistant

It describes the means for notifying the administration or Board of Trustees of known or potential conflicts, which is done in writing on an annual basis. These written notifications, along with any other potential conflicts that arise, are reviewed by management, and adjustments are made to committee assignments as needed. Additionally, voting privileges are discussed with trustees as necessary to comply with the policy and avoid any appearance of conflict.
