**Part III: Line 31- Other Program Services**

Building the Pepo La Tumaini Greenhouse and Drip Irrigation garden at Tumaini School in Isiolo, Kenya. This school is a vocational school for 100 orphans and the students used this garden as a way to raise funds for a community bank and constant source of nutrition for the students and the people in the community living with HIV/AIDS.

**(Grant \$ 3,513)**

Building the Negeya School Drip Irrigation Training Garden and Tree Nursery in Mai Mahiu, Kenya. This garden provides 1,600 with daily meals. The tree nursery is used as a way to repopulate a community of 9,000 people with indigenous trees and consists of over 300 different species of trees.
