The Education program enriches Club members culturally, socially and artistically. The Education Program held a number of programs throughout the year designed to culturally and artistically enrich its members. Programs and meetings were presented on the following topics during 2009: Art, Civics, Music, Antiques, Arts and Crafts, Biblical Literature, Book Discussions, Choral, Writing, Language, Finance, Garden, the constitution, animal preservation, Physical Fitness and Photography.

The Philanthropy program provides assistance to various charities selected by Club members throughout Cincinnati. During 2009, the Club provided support to American troops in Iraq through its "Project Care Package" program. The club was able to provide approximately 80 military boxes. In addition, the Club donated to various Cincinnati Organizations throughout 2009. In addition to the monetary donations provided, the Club contributed a number of service hours and non-monetary donations to various organizations throughout Cincinnati. Service hours consisted of performing administrative duties, tutoring students, driving disabled individuals to appointments, and various tasks for the Organizations served by the Club. Non-monetary donations include school supplies for crayons to computers, Glad house birthday kits (approx. 35), diapers and toilet tissue to My Neighbors Place, eyeglasses (approximately 151, which were subsequently distributed to the needy around the world), Socks and Mittens (approximately 400 pairs of socks and mittens were collected for distribution by the Salvation Army, members made hundreds of pillows, hats and vests for grieving children at the Ronald McDonald house. Non-monetary donations were provided to various organizations throughout Cincinnati.
