(iii) Each voting member is entitled to one vote. Each non-voting member is not entitled to vote.

(c) The terms and conditions of the proposed merger are as follows:

(i) Effective January 1, 2010, (i) the constituent corporations shall merge into a single corporation, in accordance with the plan of merger required by the Nonprofit Corporations Act ("Act") Section 701(1) and adopted by the constituent corporations as provided in Act Sections 703(1) and (2) and the applicable provisions of the Act, by Jewish Apartments & Services Foundation merging with and into JHA Development Services, Inc.; (ii) JHA Development Services, Inc. shall be the surviving corporation; (iii) the separate existence of Jewish Apartments & Services Foundation shall cease and its membership shall be terminated; and (iv) the separate existence of JHA Development Services, Inc., with all its rights, privileges, immunities, powers, as well as its membership, shall continue unaffected and unimpaired by the merger.


