Art and industrial design education for approximately 640 full and part-time students. MIAD achieved the maximum standard for reaccreditation from the Higher Learning Commission. This renewal for ten years was, in part, due to an improving four-year graduation rate of nearly 50%, an exceptional graduate employment record in spite of the recession and a loan default rate of less than 5%.
