CorpCare takes these donated items, sorts and then redistributes these to people in need through its network of other non profit and governmental organizations. This merchandise is never sold and must be used for the care of or given to the poor, the ill or children. Most donating corporations provide CorpCare with a valuation of the merchandise they contributed either based on their cost basis or some other valuation method. When no valuations are provided by the donor (which rarely happens), CorpCare estimates a value by comparing the merchandise donated to similar merchandise being sold in retail stores or through on-line retailers.
