The University seeks to develop a robust Christianity based on a Christian world view developed through a meaningful, integrated general education core program. It offers 32 majors, 26 supporting programs and 32 minors which are designed to be ministry-focused, training students to serve God in a variety of ways according to their calling and gifts. Program focus at North Central is particularly upon urban and international settings, utilizing the urban context of the campus as a laboratory for effective ministry and providing a full array of creative international learning opportunities. North Central is a coeducational, undergraduate, primarily residential college owned and operated by 11 Assemblies of God districts of the upper Midwest. Founded in 1930, the University presently serves a population of 1,100-1,250 students.
