Grantmaking: The Foundation's grantmaking has helped women and children across the greater Kansas City area access the services they need by awarding grants to various local non-profit organizations. The Foundations's grants have enabled agencies to mentor girls, provide skills and knowledge for self sufficiency, gain business skills, develop skills for making financial decisions and financial literacy, explore career fields and meet career goals.

Educational Programs: The Foundation's educational programs include a girls grant project and a giving circle. Through the girls grant project, over 33 teen girls from high schools across the greater Kansas City area learned all about philanthropy including grantmaking, fundraising, leadership, team building, program evaluation and budgeting. The girls were given the tools and resources to make grants on behalf of the Foundation. As part of the giving circle, over 25 young women came together to learn about philanthropy, grantmaking and area nonprofits. The giving circle brings full circle the financial resources and talents of young women to promote opportunities for young women, and to benefit organizations serving women and girls through grant awards.

In September 2009, the Foundation published Voices from the Heart of America: Concerns, Needs and Priority Issues Involving Women and Girls as part of the Foundation's overall mission to promote equity and opportunity for women and girls in the Greater Metropolitan Kansas City area. This publication resulted from extensive research on issues confronting women and girls in the area currently and as compared to the Foundation's initial research study from the early 1990's.
