Form 990, Part VI, Section B, line 12c		Any director, principal officer, of member of board of regents with governing board delegated pow ers, w ho has a direct or indirect financial interest, as defined below , is an interested person After disclosure of the financial interest and all material facts, and after any discussion with the interested person, he/she shall leave the governing board or committee meeting w hile the determination of a conflict of interest is discussed and voted upon The remaining board or committee members shall decide if a conflict of interest exists An interested person may make a presentation at the governing board or committee meeting, but after the presentation, he/she shall leave the meeting during the discussion of, and the vote on, the transaction or arrangement involving the possible conflict of interest The chairperson of the governing board or committee shall, if appropriate, appoint a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement After exercising due diligence, the governing board or committee shall determ ine w hether the organization can obtain w ith reasonable efforts a more advantageous transaction or arrangement from a person or entity that w ould not give rise to a conflict of interest If a more advantageous transaction or arrangement is not reasonably possible under circumstances not producing a conflict of interest, the governing board or committee shall determine by a majority vote of the disinterested directors w hether the transaction or arrangement is in the organization's best interest, for its ow n benefit, and w hether it is fair and reasonable In conformity with the above determination it shall make its decision as to w hether to enter into the transaction or arrangement If the governing board or committee has reasonable cause to believe a member has failed to disclose actual or possible conflicts of interest, it shall inform the member of the basis for such belief and afford the member an opportunity to explain the alleged failure to disclose If, after hearing the members response and after making further investigation as w arranted by the circumstances, the governing board or committee determines the member has failed to disclose an actual or possible conflict of interest, it shall take appropriate disciplinary and corrective action
