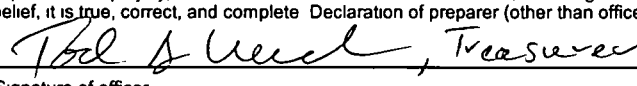

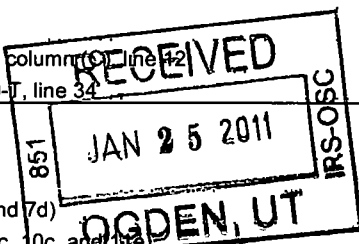

Each region hosts one statewide meeting per year, which are considered opportunities for members to invite guests/potential new members, to introduce them to CPN. The Western region hosts the statewide meeting in February, the Eastern region hosts the June meeting and Piedmont is the host for the September meeting. Statewide meetings are normally held on the third Thursday of the month at 4:00 pm, although there are occasionally exceptions. The venue is usually a facility or site of particular interest to the construction industry, and the speaker/program should also be relevant to CPN members.

In order to assist in the education of the future leaders of the construction industry and to create an alliance between themselves and the North Carolina institutions that provide construction industry education, the membership of the Construction Professionals Network of North Carolina, Inc. (CPN) establishes an annual scholarship award.

The organization has developed a program named CPN Institute that seeks opportunities to share our diverse knowledge base with the construction industry and communities in North Carolina. This program will identify key issues related to industry performance, economic development, the betterment of the construction industry and the communities it services. The program responds to these issues with research, educational programs, community services and comprehensive studies, with a focus on leveraging the unique talents of CPN members for the benefit of the public.
