Instructional - Riverside Military Academy (RMA) is an all-boys college preparatory boarding school serving students in grades 7-12 There are approximately 400 cadets from about 25 states and 13 countries The average class size is 14 students This individualized attention and highly structured environment prepares the cadets for college, military service, or success in many occupational fields Of the 69 seniors, 67 are attending 43 different colleges/universities Two entered the military The graduating class received over \$4 0 million in collegiate and athletic scholarships to colleges and universities spanning the United States, Mexico and Canada There are a total of 38 faculty members, 27 of these have advanced degrees

Athletics - RMA competes in seven Junior Varsity and one Prep level sports The Academy also competes within Region 8-AA of the Georgia High School Association (GHSA) in 12 varsity level sports The basketball team was the region runner up and advanced to the state playoffs The swim, wrestling, track, tennis and football teams all advanced to the state playoffs In total, 202 cadets received letters in varsity sports Two students accepted athletic scholarships to NCAA schools

Student Services - The vast majority of the cadets live on the 206-acre campus The campus facilities include dormitories, classrooms, a visual and performing arts center, library, gymnasium, an extensive weight-training facility, an indoor rifle range, cafeteria and grill, bookstore, swimming pool, tennis courts, and lighted athletic fields The school offers 20 different clubs and activities for cadets to participate The school cafeteria provides three meals a day Monday-Saturday and two meals on Sunday They serve all of the cadets and approximately 50 members of the faculty and staff
