***Agreement Creating the Endowment Fund of Elachee Nature Science Center
Approved by Elachee Board of Trustees September, 2004***

Whereas, the Board of Trustees of Elachee Nature Science Center, Inc (ENSC) has resolved to establish an Endowment Fund (the Fund) to enable ENSC to more completely fulfill its mission, and

Whereas, the purpose of the Fund is to provide in perpetuity, a source of funds that will develop and enhance ENSC's programs and properties beyond that which is possible through its annual operating funds,

Now, therefore, be it resolved that the following Endowment Fund Agreement (the Agreement) is hereby adopted:

Section 1. Establishment of Fund. A Fund is hereby established by this Agreement. The Fund shall be kept separate and apart from any other funds of the Center, and shall be received, used, or expended only in the manner provided for in this Agreement and in any rules and regulations which may from time to time be adopted by the Board of Trustees. The Fund shall be known as "The Endowment Fund of Elachee Nature Science Center" or other such name as the Board of Trustees of Elachee shall from time to time determine. The initial guidelines and policies (including but not limited to those with respect to investments) for the Fund must be approved by a majority of the Board of Trustees of ENSC. The Fund shall include, but not be limited to, the Elachee/Mark Trail Endowment Fund administered by the North Georgia Community Foundation. Any amendments to such initial guidelines must be approved by no fewer than sixty percent (60%) of the members of the Board of Trustees of ENSC

Section 2. Endowment Trustees. The Endowment Trustees shall be a committee composed of no more than five (5) and no fewer than three (3) members who shall be nominated by the Chairman and approved by a majority vote of the Board of Trustees for renewable terms. The initial term of the Endowment Trustees shall be as follows: two members shall be appointed for an initial term of six years, two members shall be appointed for an initial term of 4 years, and one member shall be appointed for an initial term of two years. With Board of Trustees approval, the Endowment Trustees shall develop a specific investment policy and shall be charged with the authority and responsibility for investing funds, and for approving distributions to ENSC. A quorum shall consist of at least a majority of the members of the Endowment Trustees. The Endowment Trustees committee shall meet at least two (2) times per fiscal year, and at least ten (10) days' prior notice of meetings shall be given to the Endowment Trustee Committee members. The Endowment Trustees shall, prior to the beginning of each fiscal year, elect one (1) of its members to serve as the Chairperson of the committee for such fiscal year

Section 3. Endowment Development Committee. The Endowment Development Committee shall be composed of no more than eleven (11) and no fewer than five (5) members who shall be nominated by the President and approved by a majority vote of the Board of Trustees for a term of three (3) years. The initial term of the Endowment Development Committee shall be: four members shall be appointed for an initial term of three years, four members shall be appointed for an initial term of two years, and three members shall be appointed for an initial term of one year. Notwithstanding anything contained herein to the contrary, the Chairman and the Treasurer shall automatically be deemed members of the Endowment Development Committee. The committee shall be charged with the authority and responsibility for soliciting endowment funds.

Section 4. Annual Report/Audit. A report of the Endowment Trustees Committee activities and the status of the Fund shall be presented annually to the Board of Trustees of Elachee. Further, the books and records of the Fund shall be reviewed annually by a firm of independent certified public accountants.

Section 5. Powers and Liabilities. Members of the Endowment Trustees Committee shall only be liable for their gross negligence, willful misconduct or provable fraud, and such liability shall be on a several and individual basis.

Section 6. Amendment. This Agreement may be amended only by the Board of Trustees of Elachee and, to be adopted, the amendment must be approved by a vote of no fewer than sixty percent (60%) of the members of the Board of Trustees of Elachee, voting either in person, at a duly held meeting, or by proxy at such meeting.

Section 7. Fiscal Year. The Fund shall have the same fiscal year as the center.

Section 8. Termination of Fund. If Elachee ceases to be a qualified charitable organization, assets of the Endowment Fund shall be distributed in such a manner and to such organization or organizations in the Northeast Georgia community as satisfies the requirements of a qualified charitable organization and serves purposes similar to those of Elachee.

Section 9. Pre-Existing Policies. This policy supercedes and replaces any pre-existing or current policies.

***Elachee Nature Science Center Endowment Fund Allocations Policy
Approved by Elachee Board of Trustees September, 2004***

Allocations of funds available for distribution will be made in two general ways

1. Upon written request of the President/CEO, and with the approval of the Elachee Nature Science Center Board of Trustees, funds may be transferred to the Elachee Nature science Center Treasurer for those special purposes which are consistent with the policies of the Endowment Fund.
2. As set forth in the enabling resolution, the Endowment Trustee Committee may obligate monies for general expenses incident to the management and administration of the Fund. Extraordinary initiatives contemplated by the *Board of Trustees (delete)* **Endowment Committee** for development activities will be approved by the Elachee Nature Science Center Board of Trustees before implementation.

The funds available for distribution during any one year will be limited to a designated percentage of the market value of the portfolio based on a three year rolling average, with portfolio measures taken at the end of each of the preceding twelve quarters. The market value for this purpose will be taken net of the fees for investment management. All other expenditures, whether in categories 1 or 2 above will be taken from funds available for distribution.

The designated percentage value for funds distribution will be determined each year on a timely basis by the Endowment Trustees Committee.

Any **unrestricted** unexpended funds from those available for distribution in a given year will be accrued and will continue to be considered "available for distribution" in subsequent years, unless otherwise designated by action of the Endowment Trustees after considering the advice of the Board of Trustees

The Endowment Trustees Committee shall retain the right to dissolve the Elachee endowments and use the principal for general purposes or for the restricted purposes contained in each endowment when, in the Trustees' discretion, the purposes of the endowment can no longer be met or the organization's needs may so require.
