Education, General/Other: The Hendrix-Murphy Foundation presents on- and off-campus programs that enrich the study of literature and language at Hendrix College, including but not limited to the following: lecture series (four to eight lecturers per year), visiting poet series (one to two poetry readings per year), campus writing center, language house, master works reading and writing seminar, marathon classical and other literature readings (four to six per year), foreign, British, Hispanic, and contemporary film series (six to fifteen films per year), writing across the curriculum (faculty workshops), writing center (student tutors), creative writing and visual art and playwriting competitions, and German, Spanish, and Classics travel grants, London study program (spring semester), theatre student travel to Alabama Shakespeare Festival in Montgomery (annual), undergraduate research travel fund (annual), Hemingway Museum trip (biennial), Faulkner country pilgrimage (biennial), and literary period festivals (quadrennial). Off-campus programs include student/faculty trips to Oxford, Mississippi, to explore the home and environs of Nobel laureate William Faulkner, to London, and to U.S. undergraduate research conferences in African studies and other literary and linguistic topics. Other programs include a new team-taught interdisciplinary course, Transitions, in which students and faculty both teach works that are set in urban areas or explore urban issues, student/faculty workshops in Hispanic poetry and classical readings about urban life in ancient Greece, a reading group on the formation of a hybrid language known as Spanglish, competitions in literary and visual art, playwriting, and book collection building, and support of honor societies in English and in foreign language.
