Past presenters include Ron Clark, Disney's "2000 Teacher of the Year", Dr. Jack Canfield, author of the Chicken Soup for the Soul series, Dr. Robert Brooks, self-esteem expert and author, and Dr. Michele Borba, noted author and NBC "Today Show" parenting contributor.

ST. LUKES Junior League volunteers are trained to operate the Vecta Distraction Station at St. Luke's Hospital-The Woodlands. The Vecta Distraction Station is a multi-sensory unit that provides distractions to pediatric patients undergoing treatment at hospital.

THE WOODLANDS CHILDREN'S MUSEUM Junior League volunteers sponsor monthly literacy activities and field trips to the museum for students who may otherwise not get to visit. Visit "Read-a-lot Kingdom" where dress ups, puppets, and Fairy Tales come alive and writing your own book is only an idea away.
