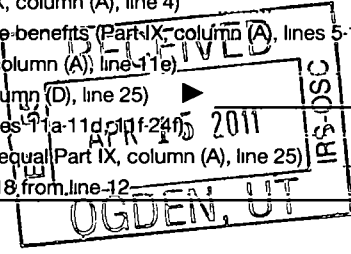

FPA Anaheim 2009 - FPA Anaheim is an organization-wide effort that is the single largest non-dues revenue source for the association. The event spotlights FPA's core competencies of: Knowledge, Community, Advocacy and Leadership. As expected due to economic conditions, attendance at the event was down with registration revenues off budget by close to \$425,000 with total registrations at 2248. Coming off such a high with Boston, this was disappointing to the organization and had a ripple effect financially within FPA. Many exhibitors expressed their displeasure with the exhibit hall traffic but had an overall positive experience with the target audience. The Professional Development Pavilion in the exhibit hall offered attendees additional education and CE opportunities, with several sessions' standing room only. The focus

FPA Retreat 2010 - FPA Retreat is a long-standing tradition within FPA. It is an event that attracts the "best and brightest" of the profession due to its level of intimacy, community learning and advanced, cutting edge content. Retreat this year represented a highly positive turning point due to its great performance. Registration revenue exceeded budget by approximately \$45,000. The sponsorship model was adjusted to maximize revenue opportunities and ensure an excellent experience for sponsors and attendees alike. Cost savings managed by the Meetings department contributed to the overall positive net revenue results for the organization.
