Program Services

Child Foundation helps children in need in Iran, Afghanistan and Indonesia to remain in school.

Education can move a child beyond the stigma of poverty and give that child the tools to reach his/her potential. Child Foundation has provided primarily food items to children living in hardship enhancing the quality of life for these children and their families.

By providing education, Child Foundation hopes to eliminate children leaving school prematurely, and in some countries early matrimony. Child Foundation has sponsorship programs primarily in Iran (over 90%), Afghanistan, Indonesia, serving over 2,500 children and families. A number of these children are enrolled in university or college programs.

There are four different programs for children with special needs. There are programs for children who have been abused, children who are visually impaired, deaf or have other medical needs, including cancer.

Child Foundation operates under the laws and regulations of the United States Department of Treasury, Office of Foreign Assets Control, pursuant to 31 CFR 5560.210 (b) Humanitarian Donations that states "The probations of sections 560.204 and 560.206 do not apply to donations by United States persons of articles, such as food, clothing, and medicine intended to relieve human suffering."

Child Foundation is actively working to support three of the United Nations 2015 Millennium Development Goals: to eradicate poverty, to achieve universal primary education and to promote gender equality in the classroom. Child Foundation believes that education can help a child move beyond the stigma of poverty, and give that child the tools to reach his or her potential.

Child Foundation's basic philosophy of operation is that "Education is basic human right which should be accessible to all children regardless of race, gender, class status or economic background and education is a gift that lasts a lifetime."
