Located at the Assistance League of Santa Ana's facility, provides low-cost dental care to uninsured students from kindergarten through twelfth grade. Last year over 2,000 dental procedures were performed, including examinations, teeth cleaning, full mouth x-rays, fillings, root canals, and extractions. The Dental Center is staffed by licensed dentists, dental hygienists, bilingual office staff, and volunteers. Patients receive individual instruction on proper oral care and nutrition and are given a dental hygiene kit by the volunteers. In addition, a volunteer dentist and hygienist provide dental screenings at community health fairs, screenings necessary for children to enter the California public school system, and educational materials to children in Santa Ana schools.
