The Community Support Program meets the needs of adults and families who experience severe and persistent mental illness, trauma, emotional and behavioral problems. Consumers are provided with support and assistance in the community. We offer non-traditional outreach, as well as specialized group services. In addition, providers offer quality of life services to mental health consumers who reside in area boarding homes. Kennebec Behavioral Health offers services in support of the consumer's recovery, thereby improving quality of life, functioning, health and vocational opportunities. Program staff advocate as necessary. Services are primarily delivered in the community or in alternative environments which are safe.

4b (Code:) (Expenses \$ 4,874,976. including grants of \$) (Revenue \$ 4,696,800.)

Med Management Program - Appropriate medical administration, prescriptions, medication monitoring, reviews, supports and evaluation of possible medication side effects are services which are provided. Services help identify psychiatric or psychosocial problems, and recommendations can be made regarding appropriate management and referrals. Services are coordinated with primary care providers.

Kennebec Behavioral Health operates Residential Supported Housing Programs in Augusta and Skowhegan. These are apartment buildings with units reserved for people with severe mental illness who need intensive supports to maintain community tenure. These are independent apartments where tenants can receive necessary skills development and supports for successful community living.


