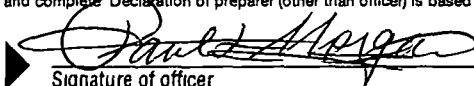
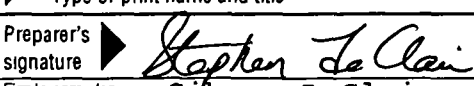

In addition, WIC provided supplemental food and nutrition education and services to over 5,947 participants.

 Service Area 2 (Housing Development and Housing & Energy Services) - PROP home services are provided in Cumberland and York counties and include fuel assistance to 6,500 households (in Cumberland County only), 365 homes weatherized, 38 homes receiving home repair work and 109 homes receiving repair/replacement services of malfunctioning central heating systems. These services also included the management and rental of low-income housing units.

The Woman's Project provides case management services to women affected by substance abuse - 253 new admissions with 463 served. Additionally we responded to 178 requests from other agencies for information and referral on matters related to Maine women affected by substance abuse.
