Briefly describe the organization's mission

Lund Family Center is a statewide organization that operates in all of Vermont's 14 counties. The mission is to help children thrive by serving families with children, pregnant or parenting teens and young adults, and adoptive families. Lund focuses on three goals: reducing child abuse and neglect, strengthening families, and helping to create new families through adoption. From its inception back in 1890 as "The Home for Friendless Women" Lund Family Center has worked for the past 120 years to improve the lives of women and children. Lund Family Center has evolved over the years to meet the changing needs of society, all the while, staying true to our mission of helping children thrive. Lund is a comprehensive parent/child resource and is a designated Parent Child Center for families in Chittenden County. Lund Family Center is also Vermont's oldest and largest private non-profit adoption agency and has completed more than 8,700 adoptions. The program is licensed by the State of Vermont.

The Residential and Community Treatment program, which is licensed by the State of Vermont, offers a comprehensive approach to working with pregnant and parenting young women, their children, and other key family members. In fiscal year 2010 the organization provided: - therapeutic residential treatment for 75 women and their 68 children and - therapeutic outpatient treatment for 68 women and their 36 children. Outcomes in 2010 included: - 100% of babies born at Lund were born substance free, - 100% of babies born at Lund were born within normal gestation period, and - 95% of the women who made planned discharges from Lund's residential and community services did not relapse within 6 months after their discharge.

Lund Family Center delivers a continuum of services in the most accessible way possible to children and families throughout the county. In addition to what is offered through Adoption and Residential and Community Treatment, the organization provided the following services in fiscal year 2010: - quality, affordable childcare and early education for 55 children and their families, - teen pregnancy prevention panels to 1,759 teens at 34 schools and community centers, - Reach Up welfare to work programming for 240 adults and 309 children, - home visits to 188 at-risk families, - high school, GED, and college support education for 42 pregnant or parenting students.

Lund Family Center's nationally awarded Adoption program, which is licensed by the State of Vermont, offers comprehensive lifelong services for birth parents, pre-adoptive and post-adoptive families, and adoptive children. In fiscal year 2010 (July 1, 2009 to June 30, 2010) the organization provided: - permanent homes for 187 children through adoption services, including 158 children who had been in foster care, - comprehensive post-adoption services for 536 children and family members, - search and reunion services for 1,161 individuals, - birth mother counseling to 30 birth mothers.
