Tax positions that meet the more-likely-than-not recognition threshold are measured as the largest amount of tax benefit that is more than 50% likely of being realized upon settlement with the applicable taxing authority. The portion of the benefits associated with tax positions taken that exceeds the amount measured as described above is reflected as a liability for unrecognized tax benefits in the accompanying statement of financial position, along with any associated interest and penalties that would be payable to the taxing authorities upon examination. The adoption had no effect on VCCI's net assets. Interest and penalties associated with unrecognized tax benefits are classified as additional income taxes in the statement of activities. VCCI files an income tax return in the U.S. federal jurisdiction. As of June 30, 2010, there were no material unrecognized/derecognized tax benefits or tax penalties or interest. With few exceptions, VCCI is no longer subject to U.S. federal, state and local, or non-U.S. income tax examinations by tax authorities for years before the year ended June 30, 2007.
