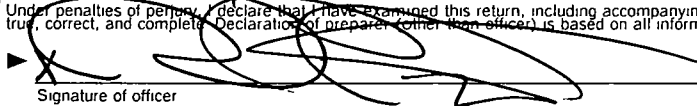

The Outreach Program conducted 27 presentations with 43 children and 36 adults. Staff members responded to 152 requests for information or referrals by telephone.
