Mothers and their children can escape from violence, people can get back on their feet after an emergency or natural disaster. Food can be put on the table of a working family, overnight shelter, and programs can offer a helping hand to navigate the day-to-day complexities of life. Twenty-seven partner agencies are supported by the funds raised during a campaign year.

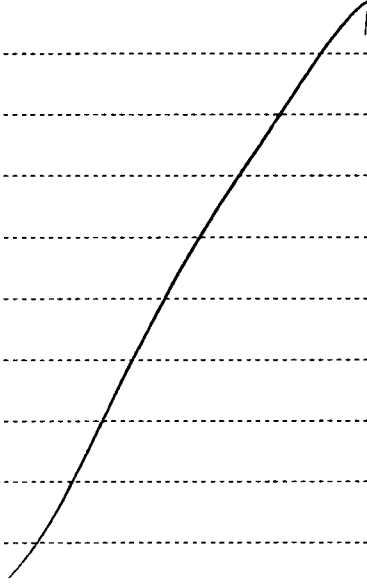
