Dove's 90-day emergency shelter program offers many services to both women and children who have experienced domestic violence, including 24-hour crisis hotline services, legal advocacy, support groups, case management, children's services, mental health and substance abuse services, and an after care program. During 2009, our emergency shelter program served 67 women and 45 children.
