FOOD DISTRIBUTION - DURING THE LAST FISCAL YEAR, WHICH ENDED ON JUNE 30, 2010, THE FOOD BANK DISTRIBUTED A RECORD 9.7 MILLION POUNDS OF FOOD TO ITS 186 MEMBER AGENCIES WITH 273 PROGRAM SITES. MOST OF THE FOOD DISTRIBUTED, 83 PERCENT, WAS CORE, NUTRITIOUS FOOD INCLUDING FRESH PRODUCE, GRAINS, PROTEIN AND DAIRY PRODUCTS.
