WHITBY'S MAIN GOAL IS TO PROVIDE A SUPERIOR, WELL-ROUNDED EDUCATION WHILE TEACHING THE IMPORTANCE OF COMMUNITY SERVICE, AND GUIDING STUDENTS IN GAINING THE ACADEMIC, EMOTIONAL AND SOCIAL SKILLS REQUIRED IN A GLOBAL COMMUNITY. WHITBY STRIVES TO PROVIDE THE MOST EFFECTIVE TEACHING APPROACHES, AND ITS INTERNATIONAL BACCALAUREATE (IB) CURRICULAR PROGRAMS OF STRUCTURED INQUIRY ARE TAILORED TO THE MATURITY AND INTELLECT OF EACH CHILD.
