Mobile Crisis-provides a mobile crisis clinician and respite bed to four mental health agencies in the south central part of the state. Mobile crisis services are provided in the evenings and weekends.

Latino Project-provides for the improvement of behavioral healthcare for bilingual Latinos and the permanent expansion and enhancement of culturally relevant treatment alternatives for the monolingual population of Connecticut. Funding is provided to five organizations throughout central Connecticut to provide these services.

Tobacco Cessation Program-provides education and support services to adults with serious mental illness interested in reducing or quitting their tobacco use. In addition, the program addresses organizational change related to tobacco use to promote a safe and healthy environment for both clients and staff. Services are provided through subcontracts with four mental health agencies.
