Foster care services - help families heal in an environment that is peaceful and inviting Each year we work with more than 500 children who are in temporary foster homes, with the goal to reunite them with family members whenever possible We are dedicated to giving birth parents the help and support they need to reclaim a permanent place in their children's lives The department is comprised of five distinct programs Foster Boarding Home, Foster Boarding Homes (RIP), Medicaid, Preparing Youth for Adulthood and Foster Parent Support Foster Boarding home expenses cover children's living costs, foster parent recruitment and stipends, and caseworker salaries, among other expenses Medicaid pays for children's medical and mental health needs Preparing Youth for Adulthood helps young people ages 14 to 21 develop the personal resilience and social resources they need to thrive outside foster care

Preventive Services - help highly stressed families address challenges before they escalate into full-blown crises The goal of Preventive Services is to help families avoid the foster care system and connect parents and children with the resources they need to thrive Preventive caseworkers help families identify and address issues that impact their ability to be intimate and supportive of each other, from chronic unemployment to educational neglect to domestic violence Families typically receive one year of services under the Preventive program, Forestdale works with up to 75 families at any given time
