Our Lower School stress the fundamentals of literacy and mathematics in a joyful, student-focused environment, with ample time built in for social studies, science, art, music, library studies, dance, and physical education. Starting in the Middle School, Packer students participate in a school-wide laptop program, with each youngster utilizing his or her own computer, working in classrooms equipped with smart boards and other multi-media, so that technology is truly integrated as a daily part of everyone’s education. In the Upper School, students encounter a rigorous and exciting program of required and elective offerings, including sixteen different advanced placement courses for which college credit may be earned.
