Foster Care and Adoption -SCO provides temporary homes for children and teens while we move their families from crisis to safety. Our family centered approach facilitates the successful reunification of the children and their families. Our program includes THREE on-site Medical Clinics as well as Mental Health SERVICES, Enhanced Independent Living, Early Intervention and Family Enhancement Services. Baby & Me, developed by SCO to promote attachment between separated parents and their young children, has been cited as a model by the Administration for Children's Services and the Permanent Judicial Committee on Justice for Children. In fiscal 2010, we were able to safely reunite 553 children with their families and find adoptive families for more than 98 children who could not return home.

SCO ALSO DEVELOPED AND OPENED "OUR PLACE" WHICH IS A DROP-IN LOUNGE TO GIVE ADULTS WHO LIVE IN SUPERVISED RESIDENCES THEIR OWN SOCIAL OUTLET. AT "OUR PLACE" PEOPLE CAN MEET OLD FRIENDS AND MAKE NEW ONES IN A RELAXED ATMOSPHERE. OUR "OPPORTUNITIES AT HOME" PROGRAM PROVIDES SERVICES TO PEOPLE WITH DEVELOPMENTAL DISABILITIES WHO ARE ABLE TO REMAIN IN A HOME SETTING HELPING THE INDIVIDUAL TO REALIZE THEIR FULL POTENTIAL BOTH IN THE COMMUNITY AS WELL AS WITHIN THE FAMILY UNIT.

HOMELESS SERVICES - SCO PROVIDES TEMPORARY SHELTER WHILE HELPING FAMILIES AND INDIVIDUALS BREAK THE CYCLE OF DEPENDENCE. OUR SHELTERS ARE LOCATED IN BROOKLYN, QUEENS, THE BRONX AND LONG ISLAND. BESIDES PROVIDING A SAFE PLACE FOR INDIVIDUALS, FAMILIES AND YOUTH TO STAY, OUR SHELTERS OFFER A VARIETY OF ON-SITE SERVICES TO HELP RESIDENTS FIND PERMANENT HOUSING AND PREPARE TO LIVE ON THEIR OWN. WE ALSO OPERATE BROOKLYN'S ONLY DROP-IN CENTER FOR YOUTH AT RISK OF BECOMING HOMELESS. IN THE CURRENT ECONOMIC CLIMATE, MORE AND MORE NEW YORK FAMILIES HAVE BECOME HOMELESS DUE TO JOB LOSSES AND LACK OF AFFORDABLE HOUSING. IN THE FISCAL YEAR ENDING 6/30/10, SCO CONTINUED TO SERVE LARGE NUMBERS OF PEOPLE IN OUR HOMELESS SHELTERS, MORE THAN 9,000 IN TOTAL.
