CHILD WELFARE SERVICES - JCCA Foster Homes provide safe, nurturing environments while families resolve difficulties that are keeping them apart. Highly trained foster parents care for more than 800 youth in the Bronx and Brooklyn. Youth with severe emotional problems who can be maintained in the community are placed in Therapeutic Foster Homes with foster parents supported by JCCA staff. Children who thrive when surrounded by their peers are cared for in supportive Group Homes. Although our ultimate goal is to reunite children with their families of origin, it is sometimes difficult. In these cases, JCCA helps them find loving adoptive homes. Our residential programs, The Cottage Schools - Pleasantville Cottage School, Edenwald Center, Pleasantville Diagnostic Center, and Gateways - offer a highly supervised and protected environment where troubled young people find safety and structure while they work to resolve their difficulties and return to their communities as soon as possible. Pleasantville Cottage School is a coed residential treatment center that cares for 150 youngsters with emotional and behavioral difficulties. Edenwald Center is a coed residential treatment center that cares for 116 young people with emotional and cognitive problems. Pleasantville Diagnostic Center is a shortterm residential assessment and treatment center for 36 boys and girls, aged 7-15. Gateways is an intensive residential program for girls who have been victims of commercial sexual exploitation and domestic trafficking. It assists young women in gaining the skills needed to return to the community as productive, independent young adults. Bridges to Health is a community care program providing intensive, wrap-around services to youth in foster care who are medically fragile or have serious emotional problems. We connect them to a full range of services that can facilitate and maintain permanency. Services include health care integration, family/caregiver supports, and skill building.

JEWISH COMMUNITY SERVICES - JCCA has always had a special commitment to the Jewish community, especially to those struggling to build new lives and families. Today we work with Bukharan Jewish immigrants from Uzbekistan, Kazakhstan, and other parts of the former Soviet Union. Programs support families and strengthen the entire community. At the Bukharan Teen Lounge in Queens, high school teens can become Americans while honoring their cultural and religious traditions. These at-risk students meet after school to socialize and celebrate Bukharan and Jewish culture. JCCA's pioneering in-home Family Day Care program provides high-quality child care for working families and a unique entrepreneurial opportunity for those who enjoy helping preschoolers. JCCA has trained thousands of dedicated, licensed child care providers. Home-based day care now serves more than 1,200 children largely from immigrant families in Queens, Brooklyn, and Staten Island. Other JCCA programs that support the immigrant Jewish community include Partners in Caring, a counseling service for children and families experiencing difficult transitions as new immigrants. The Compass Project is a Queens/Long Island/Westchester program that serves the special needs of Jewish high school and college-aged teens, ranging from youth with learning disabilities to youth on the Autism Spectrum. Compass provides counseling, educational direction, and social support to young people making the transition to an independent future. Ametz Adoption Program works with prospective parents as they move through the complexities of the adoption process. Ametz offers workshops, advice, home studies, and follow-up visits, as well as special programs of interest to Jewish parents. Every year Ametz helps more than 500 families. Forest Hills Child Care Center offers a licensed full-day program for children aged two through five and includes a free Universal Pre-Kindergarten program. It reflects the diversity of the Forest Hills community. JCCA's Two Together tutoring program provides free, individualized tutoring to students who are seriously behind in their schoolwork. A team of more than 150 dedicated volunteers, trained and supervised by professional learning specialists, helps most students improve their skills by at least two grade levels. Tutoring is offered at JCCA's Wall Street office and in Queens. Kew Gardens Hills Youth Center is an afterschool program. The program offers college guidance, job coaching, counseling, and engages youth in positive ways.

MENTAL HEALTH SERVICES - JCCA works in the community with children and families whose problems are critical. Our services touch nearly 3,000 children and families every day. Some programs work with families whose children are at risk due to a caregiver's substance abuse. Others provide a social network for those isolated from the community, or offer 24-hour crisis intervention and home visits to emotionally fragile adolescents. We partner with schools, courts, and other community services on behalf of individual clients. With our help, many families can resolve immediate problems and keep children safely at home. Fully 98% of the youth in these programs are able to avoid foster care or long-term hospitalization.
