THE URBAN INITIATIVE FOR REPRODUCTIVE HEALTH. THIS PROJECT WAS OFFICIALLY LAUNCHED AT A NATIONAL SUMMIT HELD IN NEW YORK CITY IN THE SPRING OF 2008 AND ATTENDED BY OVER 200 PARTICIPANTS FROM 36 CITIES. THIS SUMMIT REPRESENTED THE FIRST PHASE OF THE MULTI-YEAR URBAN INITIATIVE TO IMPROVE THE REPRODUCTIVE HEALTH OF CITIES. BUILDING ON THE MOMENTUM CREATED DURING THE SUMMIT, THE NATIONAL INSTITUTE SUPPORTED FOUR REGIONAL SUMMITS THIS PAST FALL THAT BROUGHT TOGETHER ADVOCATES AND PUBLIC OFFICIALS TO DISCUSS IMPROVING REPRODUCTIVE HEALTH POLICIES AND PROGRAMS IN THEIR CITIES AND REGIONS. THESE REGIONAL SUMMITS WERE ATTENDED BY OVER 500 ELECTED OFFICIALS, PUBLIC HEALTH LEADERS AND LOCAL ADVOCATES REPRESENTING 70 CITIES AND 33 STATES FROM ACROSS THE COUNTRY.

Teen Outreach Reproductive Challenge (TORCH). In order to reach a wide range of New York City teenagers, peer educators go through a formal application and interview process and are selected from a range of schools with special emphasis on neighborhoods with the highest teen pregnancy rates. The group then participates in a 36-hour, nine week leadership training that emphasizes community organizing, group facilitating, public speaking, peer counseling, and current reproductive health issues. During the last year alone, peer educators conducted over 100 presentations, on topics including Reproductive Health, Keeping it Real With Your Doctor, Human Sexuality 101, Emergency Contraception, Body Image and Self-Esteem, Reproductive Justice, HPV, and Healthy Adolescent Relationships. Peer educators reached thousands of participants of both sexes and a wide age range throughout all five boroughs of NYC.

Messaging Project. The recent health care reform debate in Washington, D.C. has put funding for abortion care, both public and private, in the public dialogue at a level not seen in more than 30 years. The National Institute plays a critical role in that conversation through research and message development that works to ensure support for women’s access to insurance coverage for abortion care. The National Institute conducted two rounds of focus groups in five markets, including Raleigh, NC, Minneapolis, MN, Denver, CO, Pittsburgh, PA and Kansas City, MO. Participants represented a range of demographic groups, including African-American women, Latinas and Caucasian women, as well as married and unmarried Caucasian men. All groups were comprised of individuals who were aged 30-55 years old, registered voters and insured. The objective of the focus groups was to hone specific proactive messages that people can use to affirm the right to insurance coverage for abortion. Once our research and messages are completed, the National Institute will develop a Messaging Toolkit that will be disseminated to national and local through briefings, a national webinar, and presentations at national conferences.

The New York State Book of Choices (BOC) is a bilingual (Spanish and English) online resource guide for women who are unsure how to proceed with an unplanned pregnancy and need information about their options. Each year, National Institute staff update the BOC website to include the most current information available about abortion services and providers. In addition to its New York State based work, the National Institute has worked to replicate the BOC model with state organizations across the country. For the past nine years, the National Institute has coordinated the Back Up Your Birth Control (BUYBC) Campaign, the leading national educational campaign to raise awareness of and expand access to emergency contraception (EC). Each year, a partnership of leading advocacy organizations, service providers, campus activists and other community stakeholders conduct educational outreach on the annual Day of Action. Since 2001, more than 350,000 pieces of educational materials have been distributed in more than 30 states. The 2010 BUYBC Campaign focused on the many reasons why women should have affordable and timely access to EC. The National Institute directly addressed these concerns by spreading the word that EC is a safe and effective way to prevent pregnancy after unprotected sex. The campaign highlighted how EC works, who can purchase OTC EC, and sources of free and low-cost EC throughout the country.
