

## CLARISSA STAGED WORKSHOP

THROUGH THE STAGED WORKSHOP OF OUR CORE FY10 PROJECT, SEPTIMUS AND CLARISSA, RIPE TIME MOUNTED A SUCCESSFUL LAB PRODUCTION OF A WORK IN PROCESS WHICH ALLOWED US TO LEARN ABOUT THE PIECE WHILE GETTING AUDIENCES EXCITED ABOUT OUR NEWEST WORK. WE ALSO ENGAGED IN OUR FIRST CO-PRODUCTION (WITH RED BULL THEATER). IN ADDITION TO BEING A GREAT LEARNING EXPERIENCE FOR THE COMPANY, IT ALLOWED US TO PRODUCE THE WORKSHOP ON A SCALE WE WOULD NOT OTHERWISE HAVE BEEN ABLE TO DO.

OUR OBJECTIVE WAS TO ENGAGE AUDIENCES WITH A HIGH-QUALITY, COMPELLING PERFORMANCE OF A WORK IN PROCESS WHILE LEARNING WHICH ELEMENTS OF THE SHOW - FROM THE TEXT, TO THE ACTING, TO THE DESIGN - WERE WORKING WELL, AND WHICH NEEDED IMPROVEMENT.

WE MOUNTED THREE PERFORMANCES OF THE PLAY IN A 99-SEAT VENUE ON JUNE 25 AND 26, 2010. 10 ACTORS WERE INVOLVED IN THE PIECE, 1 COMPOSER, 3 MUSICIANS, 3 DESIGNERS, A DIRECTOR AND ASSISTANT DIRECTOR, AND A PRODUCTION STAFF OF 3. WE SOLD 260 TICKETS AT \$20-\$40 EACH. APPROXIMATELY 20 ADDITIONAL AUDIENCE MEMBERS ATTENDED WITH COMPLIMENTARY TICKETS.

## SEPTIMUS AND CLARISSA RESEARCH &amp; DEVELOPMENT WORKSHOP

IN OUR FY10 RESEARCH AND DEVELOPMENT (R&D) WORKSHOP OF SEPTIMUS AND CLARISSA, AN ADAPTATION OF VIRGINIA WOOLF'S MRS. DALLOWAY BY ELLEN MCLAUGHLIN, RIPE TIME DIRECTOR RACHEL DICKSTEIN WORKED WITH THE PLAYWRIGHT AND WITH COMPOSER GINA LEISHMAN TO DEVELOP THE SCRIPT, CHOREOGRAPHY, AND MUSICAL SCORE FOR THE PLAY. WE THEN SHOWCASED THE WORK IN PROCESS IN AN OPEN REHEARSAL THAT WAS FREE AND OPEN TO THE PUBLIC.

THE OBJECTIVE OF THE R&D WORKSHOP WAS TO BUILD THE CHARACTERS, NARRATIVE, AND VISUAL AND AURAL WORLD OF THE PLAY.

DIRECTOR RACHEL DICKSTEIN WORKED WITH THE PLAYWRIGHT AND 10 ACTORS IN A REHEARSAL PROCESS THAT LASTED FOR 3 WEEKS (NOVEMBER 30-DECEMBER 18, 2009).
