Our Mission is to prepare children and adults with developmental disabilities for maximum independence and integration in the community through individualized programs and services, in keeping with the philosophy and vision of our founders. We are dedicated to serving our people in an atmosphere of dignity and compassion. The Agency provides educational, treatment, training and guardianship services and facilities designed to assist individuals with developmental disabilities to become socially and economically competent. The Agency also provides rehabilitative, physical, mental and educational services and psychological diagnostic and treatment services for adults and children in the greater Rochester, NY area. The Agency runs the following primary programs: the Children's program (a school program for children ages 5-21), an Adult program (a training and sheltered workshop program) and a Clinic program which supports the children and adults.

Diagnostic and treatment services in the areas of speech, medicine/nursing, psychology, occupational therapy, physical therapy and social work are also provided (116 students)
