The Greater Savannah River Community Foundation requests that the meeting the public support test be relaxed until next year . A year and a half ago, the board had decided that we would relinquish our 501c3 status and become a fund under the Community Foundation of the Central Savannah River Area so no efforts were made to cultivate the fund donors, etc. Then last year, the possibility of being the caretaker of a \$3 million estate arose, so we delayed the process of shutting down. In May 2011, the judge ruled that our Foundation would manage the fund for this estate, so the Foundation has accepted the fund and all funds have now been put in our care. With this Fund under our oversight, the Board has become revitalized and is working to cultivate new donors and donor funds and have already been successful in establishing a couple of new funds, so believe that we will meet the public support test in 2011-2012.
