Short Form Return of Organization Exempt From Income Tax

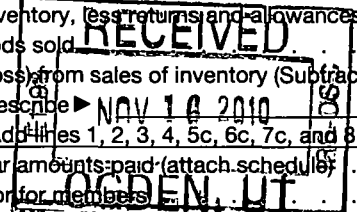


