The Agency is a public-private partnership charged with supporting, strengthening, and expanding Boston's out-of-school time system. The Agency's work creates, integrates, and leverages system-building opportunities to benefit the children and youth of Boston. It pursues this mission through its strategic functions - convening and communication, policy and advocacy, research and analysis, and networks and program innovation.

Partners for Student Success (PSS) - A partnership between the Agency and the Boston Public Schools (BPS), PSS is a multi-year initiative that aims to develop high quality, school-linked programming to ensure that struggling students in grades K-8 get the support they need to succeed. The PSS model emphasizes strong principal leadership, a lead community partner, consistent data collection, program quality observations, and coaching and technical assistance. PSS is a critical component to BPS's effort to coordinate and support school-based expanded learning opportunities in 10 schools, and serves as a model for other schools. The long-term goal of PSS is improved academic and developmental outcomes for children targeted by this effort.

Boston Youth Environmental Network - BYEN mobilizes environmental agencies in collaboration with the Boston Public Schools in order to advance career opportunities for high school students and to enhance environmental education for K-8 students in the Boston Public Schools. BYEN pilots system-building efforts to activate learning in hands-on ways and inform policy development with a variety of public and private partners.

Boston Youth Sports Initiative (BYSI) - BYSI seeks to leverage a network of programs, intermediaries, and funders to increase youth access to sports-based youth development opportunities. Specifically, BYSI supports targeted system-building efforts to increase the capacity of programs to provide quality opportunities, especially to underserved groups. The BYSI was created for the network of providers and supporters of youth sports across the city.
