	In tax year 2009, the ServiceSource Foundation raised \$514,260. The Foundation raises money through community outreach activities and events such as the Annual Spring Wine Feast in Washington, DC. One hundred percent of all proceeds raised are used to directly support programs for people with disabilities. The Foundation provides funding to support un-funded or under-funded programs of ServiceSource. Since its inception, more than \$1.2 million dollars has been allocated in direct support of ServiceSource's innovative programs for individuals with disabilities. The Foundation fully funded the purchase and renovation of the Prince William Neighborhood Place, a community-based home in which individuals learn daily living skills such as cooking, shopping, minor home maintenance and computer training. The Foundation has also funded state-of-the-art Sensory Perception Centers at ServiceSource's Day Support Programs, which serve more than 100 individuals with significant disabilities. In tax year 2009, the Foundation allocated more than \$250,000 to make security enhancements at the Edsall Road employment center, provided funding for music and dance therapy, paid for a wheelchair accessible lift van and supported a therapeutic horseback riding program in partnership with the Northern Virginia Therapeutic Riding Program. The ServiceSource Foundation also continues to sponsor ServiceSource's Annual Service Excellence Awards Program, in which ServiceSource program participants and employees with disabilities are recognized for their achievements. The ServiceSource Foundation is part of the ServiceSource Network, which is comprised of five affiliate offices, including ServiceSource in Alexandria, Virginia, Central Fairfax Services in Springfield, Virginia, Employment Source in Fayetteville, North Carolina, OCI in Wilmington, Delaware, Abilities of Florida in Clearwater, Florida. From Florida to Pennsylvania and west to Colorado, the ServiceSource Network collectively employs nearly 1,600 people with disabilities and provides employment and other support services more than 11,000 individuals. Collectively, the ServiceSource Network generated \$127.3 million in revenue in tax year 2009 to support its mission of providing individuals with disabilities an exceptional service delivery experience through innovative and valued employment, training and support services to help them become active, integral and valued members of their communities.
