Advocates for Arts-Based Education Corporation is a nonprofit entity that operates Lusher Charter School Lusher Charter School is a kindergarten through 12th grade New Orleans Public School located in Uptown New Orleans A charter school is a public school operated by a nonprofit corporation pursuant to an agreement with the local or state school board with public funding As a Type 3 charter, Lusher Charter School is a "local charter" converted from an existing public school, Lusher Elementary and Extension School, and is still part of New Orleans Public Schools In the summer of 2005, Lusher began pursuing charter status with an overwhelming vote of approval by both the parents and staff of the school as provided by the Louisiana Charter School Law Lusher submitted its charter proposal to the Orleans Parish School Board, who approved the charter application in September 2005
