BY PROVIDING SCHOOL SUPPLIES AT NO COST TO TEACHERS, SCHOOLHOUSE SUPPLIES LEVELS THE EDUCATIONAL PLAYING FIELD FOR ALL STUDENTS. THE FREE STORE FOR TEACHERS SERVES ALL 3,000 TEACHERS AND 46,500 STUDENTS IN THE PORTLAND PUBLIC SCHOOLS SYSTEM.

 TOOLS FOR SCHOOLS. THE ORGANIZATION'S TOOLS FOR SCHOOLS PROGRAM CREATES DIRECT LINKS BETWEEN AREA BUSINESSES AND STUDENTS IN HIGH-NEED K-5 AND K-8 SCHOOLS. EACH YEAR, PARTICIPATING BUSINESSES PROVIDE BACK-TO-SCHOOL BACKPACKS FILLED WITH ESSENTIAL SUPPLIES FOR STUDENTS IN PORTLAND'S TITLE I SCHOOLS, WHERE MORE THAN 65% OF THE STUDENTS ARE ELIGIBLE FOR FEDERALLY FUNDED FREE OR REDUCED LUNCH. IN THE FALL OF 2009, SCHOOLHOUSE SUPPLIES PROVIDED 8,424 BACKPACKS FILLED WITH SCHOOL SUPPLIES TO STUDENTS. PARENTS CAN PURCHASE INDIVIDUALIZED "KITS" (DURING THE JUNE-AUGUST PERIOD) THAT MATCH THE SUPPLY LIST OF THEIR CHILD'S ASSIGNED CLASSROOM. 2009 MARKED THE ORGANIZATION'S FOURTH YEAR OF SELLING SCHOOL SUPPLY KITS ONLINE, GENERATING A MODEST EARNED REVENUE STREAM AND PRESENTING DONATION OPPORTUNITIES TO A WIDER AUDIENCE. INCLUDING CONTRIBUTIONS, THE ORGANIZATION'S REVENUES FOR SCHOOLHOUSE SUPPLIES ONLINE TOTALED \$67,393. WITH DIRECT EXPENSES OF \$57,694, THE PROGRAM GENERATED A NET SURPLUS OF \$9,699 FOR THE ORGANIZATION.
