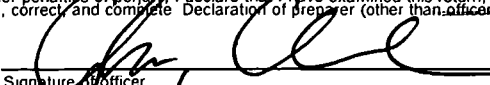

Exempt Purpose, Line 1, Organization's Mission

The Corporation is a nationwide nonprofit membership organization dedicated to promoting public policies that promote economic growth primarily through legislative involvement, issue advocacy, research, and training and educational activity and may engage in any other lawful purpose.

Statement of Program Service Accomplishments, Line 4, Program Services

a. Public Education and Research \$433,143

The organization conducts a program of public education through speeches, articles and TV and radio news interviews to educate citizens on the benefits of pro-growth policies and the work of the organization. Staff members wrote articles on topics including tax policy and excessive spending that appeared in leading newspapers and news outlets, including Politico, Human Events, Orlando Sentinel, Forbes.com, The Wall Street Journal, USA Today, and National Review Online. Staff members appeared on over 10 nationally distributed TV and radio news programs and dozens of local radio programs.

b. Publications \$239,625

The organization publishes information in print and on the Internet to educate on economic issues and motivate people to act in support of pro-economic growth policies. Its blog published over 850 entries, has been inducted into the Weblog Awards Hall of Fame and was visited by over 120,000 unique visitors during the fiscal year. It publishes a website on Social Security reforms and publishes a membership newsletter that currently has a circulation of 50,100, up 40% over the previous year. The organization also publishes information on Facebook and Twitter and has published over 160 items using the service. We also maintain a listserve on free trade issues and subscribers are primarily well known public policy advocates.

c. Legislative Involvement and Policy Advocacy \$1,250,431

The organization monitors legislation that can help or harm economic growth, and urges its adoption or rejection by Congress, the President, and state and local governments. In addition to its public education efforts, such actions for legislative involvement and policy advocacy included numerous letters to Congress and dozens press releases. It ran a TV ad campaign costing nearly \$700,000 in opposition to the health care legislation during the time it was considered in Congress due to concern about the measure's potential impact on economic growth. To further its efforts to enact pro-economic growth legislation, the organization also periodically publishes reports on congressional roll call votes on legislation that would impact economic growth for distribution to the media, its members and the public.

d. Lectures and Conferences \$489,030

The organization conducted a conference during the fiscal year on economic policies that can increase economic growth. Conference presentations were made by sixteen members of Congress, six economists and five journalists.
